Introduction

This Privacy Statement (the “Statement” or “Privacy Statement”) applies to personal information that RSCC Wire and Cable., together with subsidiaries and affiliates (collectively, “r-scc,” “us,” “we,” or “our”) collects. This includes information collected via our website (<https://www.r-scc.com/> referred to herein as “Website”).

This Statement applies to information we collect on/via the Website, whether you use the Website via a computer, mobile device, or any other platform or equipment.

It does **not** apply to information collected by us offline or through any other means, including on any other website by r-scc or any third party (including our affiliates and subsidiaries); or any third party, including through any application or content (including advertisement) that may link to or be accessible from or on the Website.

Modifications to this Privacy Statement

We generally keep this Privacy Statement on our Website. You should review this Privacy Statement frequently, as it may change from time to time without notice. Any changes will be effective immediately upon the posting of the revised Privacy Statement. WHEN YOU USE OUR WEBSITE, YOU AGREE TO THIS PRIVACY STATEMENT. IF YOU DO NOT AGREE TO THIS PRIVACY STATEMENT, OR TO ANY CHANGES WE MAY SUBSEQUENTLY MAKE, IMMEDIATELY STOP USING OUR WEBSITE.

A. INFORMATION WE COLLECT AND HOW WE COLLECT IT

When you visit our Website we may collect personal information such as:

- Information you choose to provide to us through our Website (e.g. email address, preferences, and contact information provided for user feedback purposes).
- Information about your internet connection, the equipment you use to access our Website, and usage details.

We collect this information:

- Directly from you when you provide it to us.
- Automatically as you navigate through the Website. Information collected automatically may include usage details, IP addresses, and information collected through cookies, web beacons, and other tracking technologies.

B. HOW WE USE THE INFORMATION COLLECTED

We use information that we collect about you or that you provide us, including any personal information, for or in connection with:

- Our contracted service providers that process personal information on our behalf.

- Affiliates within our current or future corporate group that process personal information for customer support, marketing, event management, technical operations and account management.
- Third-party networks and websites so that we can advertise on their platforms.
- Parties in connection with a merger or acquisition of our business.
- Public and government authorities, to the extent we are compelled to disclose personal data to comply with our legal obligations.

C. DISCLOSURE OF YOUR INFORMATION

We may disclose aggregated information about our users, and information that does not identify any individual, without restriction.

We may disclose personal information that we collect or you provide as described in this privacy statement:

- To our subsidiaries and affiliates.
- To contractors, service providers, and other third parties to support our services.
- To a buyer or other successor in the event of a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all of r-scc's assets, whether as a going concern or as part of bankruptcy, liquidation, or similar proceeding, in which personal information held by r-r-scc about our Website users is among the assets transferred. This Privacy Statement will apply to your personal information transferred to the new entity.
- To fulfill the purpose for which you provide it.
- For any other purpose disclosed by us when you provide the information.
- With your consent.
- To comply with any court order, law, or legal process, including to respond to any government or regulatory request.
- If we believe disclosure is necessary or appropriate to protect the rights, property, or safety of r-scc, our customers, or others.

D. NOTICE TO CALIFORNIA RESIDENTS AND INDIVIDUALS IN THE EEA

This section supplements the information contained in this Statement and applies ONLY to visitors, users, and others who reside in the State of California ("consumers" or "you") or individuals in the European Economic Area (EEA) ("data subjects"). Any terms defined in the CCPA or the GDPR have the same meaning when used in this Statement.

- Withdraw your consent at any time (to the extent we base processing on consent).

We will not discriminate against you for exercising any of your CCPA rights.

Your personal information may be collected, transferred to and stored by us in the United States. We have implemented safeguards to ensure an adequate level of data protection where your personal information is transferred outside of your country or jurisdiction, to the extent required by the GDPR.
